

**Contract concerning frozen semen Bingo Ste Hermelle:**

**Formula 1 per straw:**

- 1) The sales price is EUR 800.00 + 6% VAT per straw, with frozen semen to be paid in advance to the stallion owner.
- 2) Expenses of veterinarians, transport and dispatch of the semen and the distribution and delivery of a health certificate are at the expense of the mare owner.
- 3) Payments are made after receipt of the invoice and before the delivery of the straws, when the stallion owner has received this payment, your order will be passed on and shipped.
- 4) The straws of semen supplied are exclusively used by the mare owner who purchased the straw and cannot be resold.
- 5) Special conditions apply for ICSI treatment of eggs with frozen semen: see further in these conditions. The semen supplied under this agreement is not ICSI free.
- 6) If the sperm is purchased for the fertilization of eggs by applying ICSI, the following deviating price conditions apply (the other conditions in this agreement remain fully applicable):
  - a) Sale of straw semen at EUR 800.00 ex VAT per straw
  - b) Surcharge of EUR 800.00 ex VAT per live foal
- 7) The mare owner must provide the stallion owner with an overview drawn up and signed by the vet or the embryo transfer center before 30/10/2022 or after the first use of the number of successfully implanted embryos per mare. From a 2nd embryo, a surcharge of EUR 800.00 ex VAT per successfully implanted embryo after 45 days of gestation will be charged.
- 8) The mare owner must return to the stallion owner the last insemination certificate / certificate of embryo transfer signed by the vet, stating the last insemination date / date of embryo transfer, before 30/10/2022 or after 1st use.
- 9) If the mare owner commits an attempt to commit fraud, the unconditional fine is EUR 5,000.00 per case, excluding the stud fee that is also due.
- 10) In the event of a dispute or recovery, the courts of the District of Mechelen are competent.

**Formula 2 (3 cycles 2022):**

- 1) The sales price is EUR 1600.00 excluding 6% VAT per mare for the 2022 season, with frozen semen to be paid in advance to the stallion owner.
- 2) Your mare can be offered through the relevant AI centers up to a maximum of 3 stallions up to 1st pregnancy or 1st accepted embryo in surrogate mother. In these AI centers, 2 frozen straws of semen are used per insemination.
- 3) Expenses of veterinary costs are borne by the mare owner.
- 4) Payments are made after receipt of the invoice and before the mare is inseminated, when the stallion owner has received this payment, the confirmation is passed on to the relevant AI centers.
- 5) If the mare is inseminated for embryo wash. From a 2nd embryo, a surcharge of EUR 800.00 ex VAT per successfully implanted embryo after 45 days of gestation will be charged.

- 6) The mare owner must provide the stallion owner with an overview drawn up and signed by the vet or the embryo transfer center before 30/10/2022 or after the first use of the number of successfully implanted embryos per mare. From a 2nd embryo, a surcharge of EUR 800.00 ex VAT per successfully implanted embryo after 45 days of gestation will be charged.
- 7) The mare owner must return the last insemination certificate/embryo transfer certificate signed by the vet, stating the last insemination date/embryo transplant date, to the stallion owner before 30/10/2022.
- 8) If the mare owner commits an attempt to commit fraud, the unconditional fine is EUR 5,000.00 per case, excluding the stud fee that is also due.
- 9) In the event of a dispute or recovery, the courts of the District of Mechelen are competent.
